## Overview

Auditors determine the ratings based on the degree of risk or effect of the findings in relation to the audit objective(s).

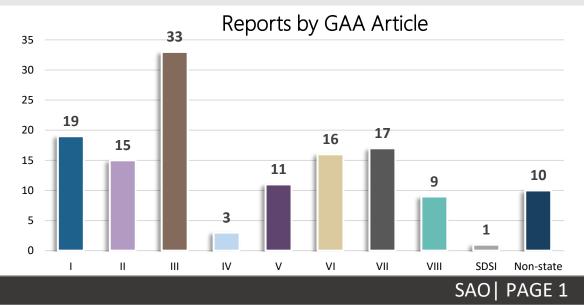

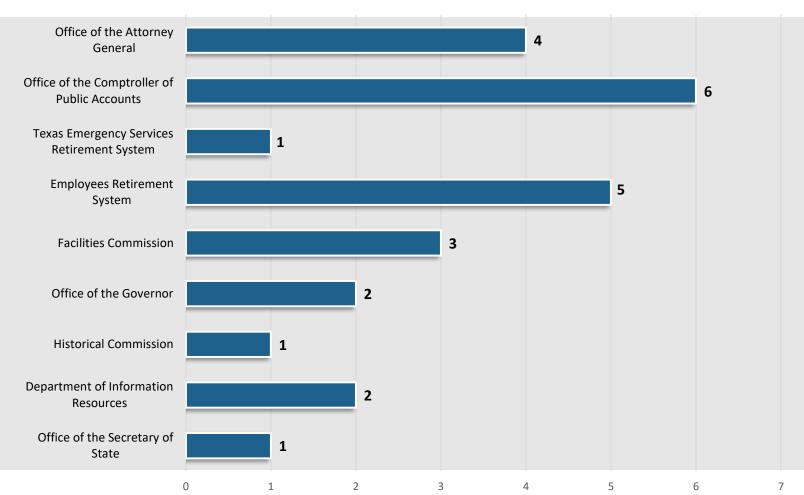

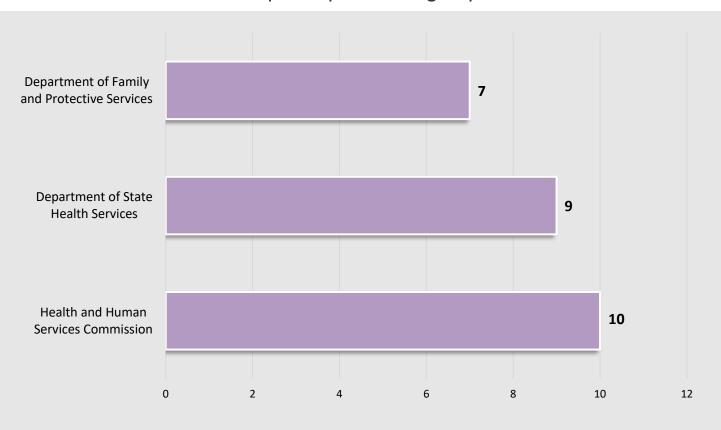

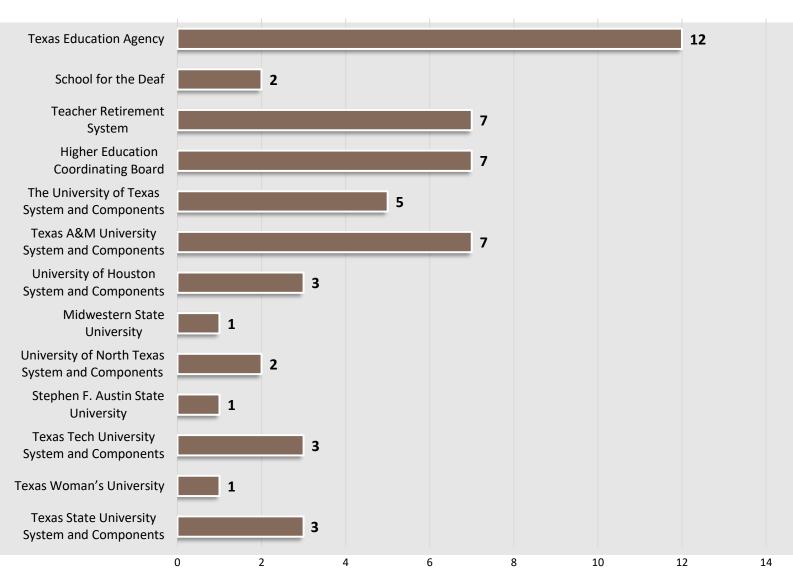

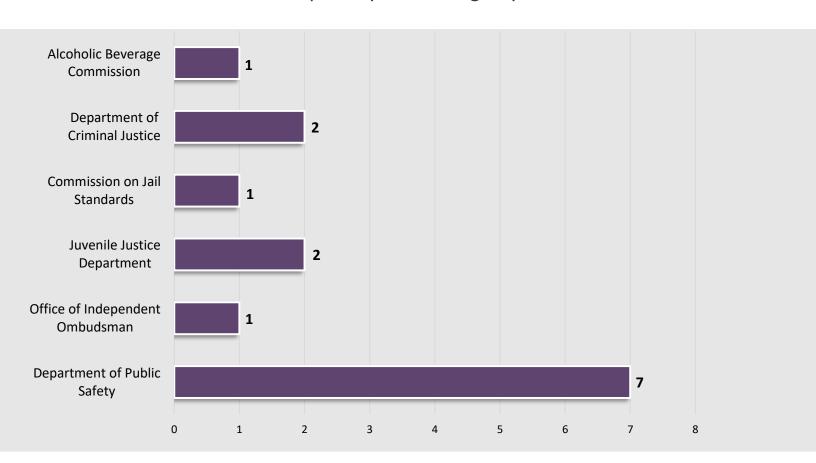

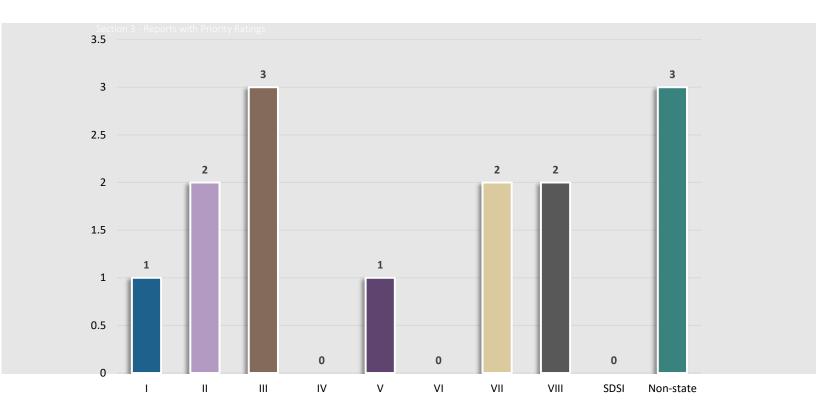

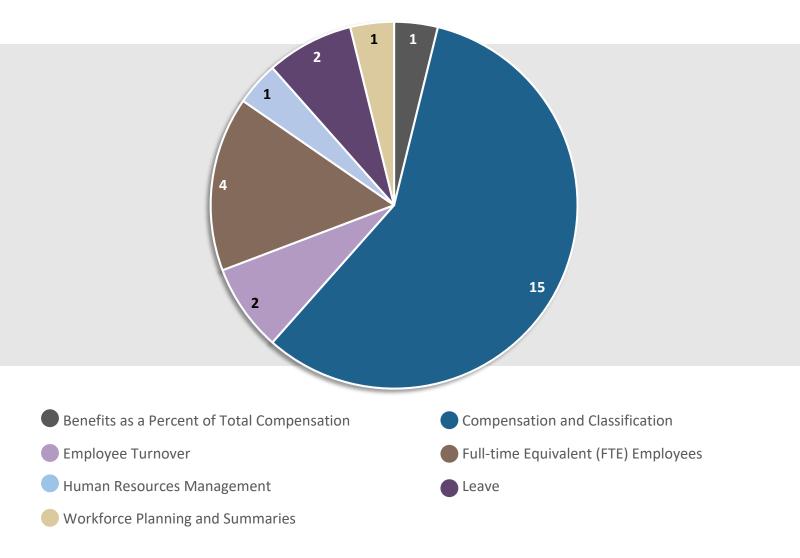
